Applications are invited from the willing & eligible bonafide Indian Nationals for **purely contractual engagement** for the posts of Veterinary Doctor, Para Vet & Attendant in Singur Block of this district under State Plan for operation of Mobile Veterinary Clinic (MVC). 1. Candidates will be essentially conversant in communication through Bengali language. Preference will be given to fresh and young candidates.
2. Applicant for the post of Livestock Attendant should be resident of Singur Block or areas adjacent to Singur block (i.e., Haripal/Dhanikhali/Chanditala-I/Chanditala-II/Serampur Uttarpura block).
3. All Applicants have to **apply online** through the website www.hooghly.gov.in. No application will be received by post or by hand or by any other means .
4. Last date of submission of online application is 25th Dec. 2017.
5. After scrutinizing the applications, list of eligible candidates with date of Interview will be hosted in the district website (www.hooghly.gov.in) & no further communication will be made for interview .
6. Only one application should be submitted by an applicant online . Multiple submission of application may lead to cancellation of application.
7. No TA/DA will be paid for appearing in the interview.

8. Original of each of the following documents must be produced along with one self attested photocopy of the document at the time of verification before interview .
 - i. Photo copy of Identity Card (Passport/Voter ID/ Aadhaar / Pan Card).
 - ii. Proof of address (Passport/Voter ID/ Aadhaar).
 - iii. All Mark sheets and pass certificates of all the essential academic and professional qualification .

Other Terms & Condition:-

1. Selected candidates will be **engaged purely on contractual basis up to 31st March 2018** subject to periodic evaluation.
2. As per posts are purely contractual , no reservation & no age relaxation under West Bengal SC/ST(reservation of vacancies in services and posts) Act, 1976 and West Bengal Backward Classes(other than SC/ST) (reservation of vacancies in services and posts)Act 2012 will be applicable .
3. The tenure of engagement may however be extended thereafter on the basis of performance and ability of the individual candidates and availability of fund.
4. The successful candidates shall not at any point of time claim to be made permanent.
5. The monthly remuneration/emoluments to the candidates will be paid from the fund received/ to be received under "State Plan".
6. The Engagement will be terminated immediately once fund is exhausted.
7. Successful candidates engaged for the post as specified earlier shall be considered as full time Contractual worker of the MVC, Singur. Successful candidates shall not be allowed to work under other any organizations.
8. Authority has the right to terminate the engagement at any point of time, without showing any reason, however a notice period of 01 (one) month shall be given from both side before termination of the engagement contract.
9. The engagement will be terminated if testimonials of the candidate found to be incorrect/ false in any stage in the future.
