RESERVATION OF POST

- The benefits for reservation of vacancies for SC, ST, OBC-A and OBC – B candidate are admissible to SC, ST, OBC-A and OBC – B candidates of West Bengal only as per existing rule. The prevalent norms for exclusion of Creamy Layer will be applicable for the OBC Candidates.
- SC, ST, OBC-A and OBC – B candidates of other States will be treated as Candidates of Unreserved categories.
- Before final selection, Short- listed candidates belonging to SC, ST, OBC-A and OBC – B category will be directed to furnish original certificate issued by competent authority of West Bengal as laid down in the West Bengal Schedule Castes and Schedule Tribes (Identification)Act, 1994 and SC Tribal Welfare Department order no. 261 – TW/EC/MR-103/94 dt. 06.04.1995, for verification of testimonials in support of their claim.
- Similarly, the Persons with disabilities (40% and above) and the EX- Servicemen Candidates shall have to produce relevant documents, in original, in support of their claim in reservation at the time of verification.
- Similarly, candidates applying for Exempted Category shall have to produce relevant documents, in original, in support of their reservation at the time of verification.
- No claim for being member SC/ST/OBC-A /OBC-B or a person with Disability or Ex- Servicemen or belonging to Exempted Category shall be entertained after submission of the application.
- Particulars and certificates required: a candidate claiming to be SC/ST/OBC-A/OBC-B/ Physically Handicapped must have certificate in support of his /her claim from a Competent Authority as Specified below: -
- **For SC/ST/OBC-A/OBC-B** candidates (vide the W.B SCs STs (Indemnification)Act, 1994 and SCs & TW Department order no. 261-TW/EC/MR-103/94 dt. 06.04.1995

- a. In the District, the Sub-Division Officer of the Sub-Division concerned, and
 - b. In Kolkata, the District Magistrate, South -24- Parganas or such Additional District Magistrate, South -24-Parganas, as may be authorized by the District Magistrate, South -24- Parganas, on his behalf.
- Names of **Exempted Category Candidates** shall ~~be~~ also be obtained by DLSC directly from Exempted Category Cell under Director of Employments, West Bengal to fill up the vacancies meant for Exempted Category candidate in terms of Provision of point no.6 as laid down in the Notification issued by Labour Department Vide Memo No. 50-Emp/1M-25/98 dated Kolkata, the 1st March, 2011
 - For Ex- Servicemen Candidates – name of Ex-Servicemen shall also be obtained both from Zilla Sainik Board as well as through online application filling up the vacancies meant for Ex- servicemen.
